Materials or tangible property purchased for use in manufacturing, processing, or fabrication of a new or remanufactured product may be purchased "wholesale" or without taxation. Natural gas and electricity for this purpose may also be purchased "wholesale" if proof is established via

a predominant use study showing the exact percentage of each natural gas or electric meter's consumption that is directly used in causing a chemical or physical change to the product that will ultimately be sold. A Predominant Use Study must reflect the balance between consumed and inventoried usage. The study is an analysis of natural gas cubic foot consumption or electric kilowatt-hour consumption of each individual meter. Additionally, it must analyze the use of gas and/or electricity of each piece of equipment as well as the processing and non-processing function for equipment having dual usage. The computations may also need to be certified by a registered engineer from an accredited college of engineering where applicable.
